• 2000: Annual CEE Insolvency Study / Panorama

Martina Dobringer initiated an annual insolvency study as early as 2000 and already underscored the importance of the region to the domestic economy at that time. In addition to insolvencies, the study also includes the number of active companies and the insolvency index. Insolvency law was highly divergent in the CEE region, particularly before EU accession of a country. The study has included an annual update of both figures and legal changes every year.

• 2003: Country Risk Conference in CEE

The first conference was organised in Vienna in 2003 to help companies make rapid, strategic decisions. Martina Dobringer rolled out this special event format in all of the countries of Central and Eastern Europe in following years. The main focus is the Coface country and sector risk assessment and forecast, accompanied by talks by a variety of experts on current challenges and trends. The conferences are now firmly established and a regular event on the event calendar in all countries.
